TERMS AND CONDITIONS

By participating in the [Bantam Estate Absolute Land Auction](#), the bidder agrees to the following terms and conditions.

FINANCING: This sale is NOT contingent upon the buyer's financing. Prospective buyers should make financial arrangements prior to the auction.

PAYMENT: The winning bidder will be required to make a 20% non-refundable down payment of the winning bid the day of auction with the signing of a Lashley Land & Recreational Brokers purchase agreement. Certified or personal check and Wire Transfer is accepted. The remaining 80% payment due at closing.

POSSESSION: Full possession of the property will be given upon closing.

TAXES: Seller shall pay the 2025 and previous year's taxes. The 2026 taxes will be paid by Buyer.

TITLE: Seller to convey title by warranty deed. Merchantable title(s) will be made available. The cost of title insurance and escrow closing fees to be divided equally between the buyer and seller. Title insurance escrow services will be provided by Southwest Title Company.

PROPERTY CONDITION: The property and improvements are selling in "AS-IS WHERE-IS" condition - no warranties expressed or implied to the condition of the property.

AGENCY: Lashley Land & Recreational Brokers are agents representing the seller.

METHOD OF SALE: This will be a Live Auction with Online Simulcast bidding available. Property will be offered [as single and combination parcels](#). The auctioneer will determine the process of the sale and bid increments accepted. The auction date will be [February 25th, 2026](#).

MINERALS: All mineral right owned by the Sellers will pass to the Buyers, if any.

ABSENTEE BIDDER REGISTRATION: Absentee bidders will be required to fill out a bid certification form before being allowed to bid. They are available on the website to download. Once completed, submit it to ellie@lashleyland.com. Completed Bid Certification Form must be returned on or before [February 20th](#), to be approved for absentee bidding.
