## Property Summary

These are excellent pivot quarters located in a strong farming area. The soils in this area are mostly Class 1 and Class 2 (irrigated) Holdrege silt loam. This area typically receives 22" to 24" of annual rainfall. Both parcels are located in the Tri-Basin NRD within the Platte watershed, and as such, have no pumping restrictions. Pivot irrigated land in this area is an excellent investment as most NRDs in Nebraska have pumping restrictions and a moratorium on new wells, so pivot irrigated farmland is only going to gain in appreciation, as they won't be making any more of it!

These pivots are fairly new, or new and the Owner/operator is dedicated to regular maintenance.

### Parcel 1: \$2,133,700 | 150.32± acres | Taxes: \$6,291.96

This parcel is comprised of 26.4% Class I soils, 48.5% Class II soils, and 23.4% Class III. This parcel has a 1981 Valley Pivot with a diesel motor on the well and generator. This parcel enjoys both surface water rights and well water rights. Owner reports that the surface water is sufficient for the majority of the growing season, making irrigation more cost effective.





# PARCEL 2 AERIAL MAP





# PARCEL 2 SOILS MAP
