

Lead Testing at 303 S. Clark St, Bassett, NE 68714

A reading of 1.0 or higher is interpreted as "contains lead".

The XRF gun can read through $\frac{3}{8}$ of an inch of material to detect lead, including layers of paint.

We tested virtually everything, but did not do a formal report. We have a full list of all tested surfaces and their readings, if you would like it. Below are just the positive results. Multiple reading values indicate that we measured multiple points on that surface.

Bathroom

Clawfoot tub - has high levels in enamel (reading: 34), typical for enamel tubs and sinks prior to 1970's.

Living Room

Wall behind cupboard next to kitchen where peeling - 0.0, 1.3 (we are guessing that there is probably some lead in repair material used on the wall)

Wall to bedroom near crack - 0.8, 0.5, by door - 1.0

West and south side of chimney - 1.0

Wall behind shelves - 1.2 but paint is in good shape

South bedroom upstairs

Exterior paint by windows - 4.7, 1.4

Bathroom

Exterior window casing - 0.9 (technically not positive, but close)

Porch

The most recent layer of green paint appears to be negative for lead. Positive readings below on surfaces painted green would be for layers underneath the recent top layer of green paint.

Storm window casing - 28.9

House siding - 32

Front door - 22.1

Front door right jamb - 25.5

Front door casing - 29.1

Swing - 2.1, 2.0

Above windows - 29.4

Window sills - 1.1

Wainscoting on ceiling and top of wall - 23.9

Basement

Stair case bottom column - 19.4

Outside

Soffat above laundry room wall - 24

All exterior wood siding we assumed positive, EXCEPT the exterior laundry room walls and the exterior garage walls, which measured 0.

We tested soil samples from the drip line at the base of the house and from the raised bed:

Soil sample results indicated levels of lead below thresholds of concern around the drip line of the house. The raised bed is safe for growing food.
